Summers (Rancho Bernardo, Inc.) invites Wilson to tour his 5400 acre city, seeks to retain a San Diego postal address & potentially may be of financial assistance to Wilson for his next campaign; a copy of the "Homes and Gardens" section of The San Diego Union (5/12/63) re/photo of "City in the County: Rancho Benardo " & article; a letter (5/20/63) from San Diego constituent Walter M. Owen and Wilson's reply (5/22/63) re/ complaint about postal service and Wilson's humorous reply; letters (Apr.-May 1963) re/responses to a local life insurance businessman's complaint about delays in receiving a daily listing service; copy of a letter (4/11/63) from Marge O'Donnell (Secretary to Congressman Bob Wilson) to Postmaster, Old Town Post Office, San Diego re/ forwarding all Wilson's mail sent to 2210 Tokalon St., S.D be forwarded to Room 114, House Office Bld., Washington, D.C.; a letter (1/9/63) & Wilson's reply (2/1/63) re/ an interesting and informative complaint about rude postal clerks from an El Cajon constituent; letters (2/63) re/ the Oceanside postmaster is retiring so a Municipal Court Judge proposes a replacement who is "a registered democrat . . . [and] highly thought of by 100 percent of the republicans in the area," but both Wilson and James Utt refer instead to letting Senator Claire Engle make the "appointments in the Congressional Districts represented by a Republican Congressman;" a Committee Print, Procedures For Appointment of Acting Postmasters, Permanent Postmasters, and Rural Letter Carriers; Consolidation of Rural Routes, Post Office Dept., Feb. 18, 1963, U.S. Government Printing Office; letters (Sept.-Dec. 1962) re/inquiry from Lee Hansen, President of the Casa De Oro Chamber of Commerce about the "feasibility of establishing a postal facility at Casa De Oro, California" rather than being serviced by La Mesa, El Cajon and Spring Valley; letters (7/12/62) from constituent Ardath Hunt and Wilson re/the Congressman making arrangements for this family to tour the White House & other buildings in Washington; a copy of U.S. Post Office, Postal Zip Code Directory Mr. Zip San Diego, Calif., POD Publication 921-63; a copy of "Text of Address to the House of Representatives on January 19, 1960, by
