11(f). I will limit the number of significant litigated matters to four.

1. A case wherein the defendant was charged with pandering and/or selling obscene material, and the book in question was the Marquis de Sade. This was a municipal court action which I tried in approximately 1966 and the trial last six weeks. In this trial appeared expert witnesses having to do with literary value and the history of languages. This case was prosecuted by attorney Kenneth Lounsbury, presently City Manager for the City of Escondido, 100 Valley Boulevard, Escondido, California, 92025, (714) 741-4631.

2. People v. Davis, 62 Cal.2d 791. I represented the defendant in this case prior to becoming a judge on the charge of murder. The verdict of the jury was that the defendant should be put to death. During the course of the trial I made an offer of proof of the testimony of two psychologists who were prepared to testify that the defendant suffered a temporary psychosis which rendered him unable to reason right from wrong; that is, temporary insanity. The trial judge, William P. Mahedy, now retired, refused to hear or decide the issue of whether or not said psychologists were competent. In the appeal, the appellate court ruled that psychologists, if competent, should be allowed to testify, and I believe this is a landmark case, in that this was the first time the California Supreme Court so ruled. The prosecutor in this case was John C. Van Benthem III, who is now in private practice in the City of San Diego.

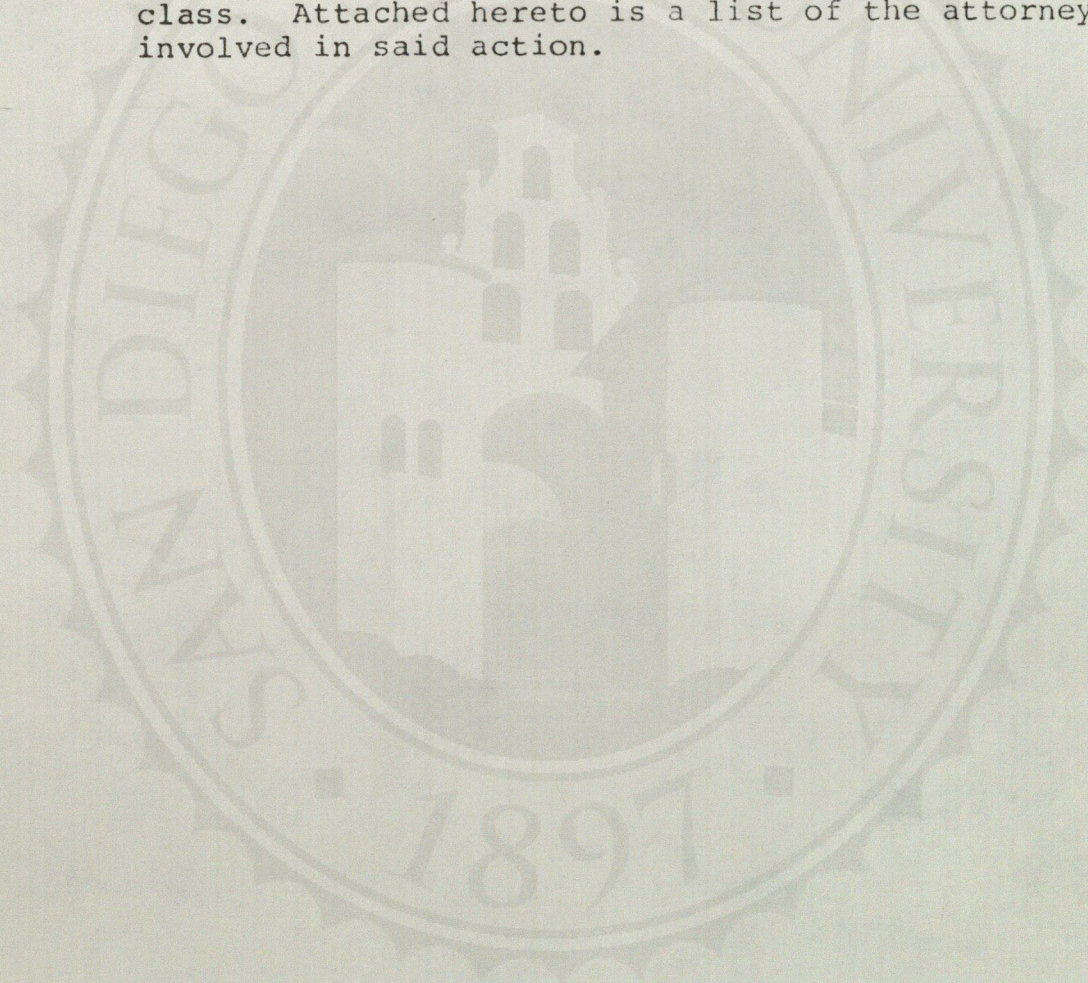
3. Cesco Development Corp. and Conde Investment Corp. v. Citizens Development Corp., et al.
San Diego Superior Court Case No. 3926 N

This was a court trial which took more than six weeks to try, and I tried this case in the latter part of 1977. The damages in this case could well exceed \$8 million; the issue being whether or not the plaintiff should be entitled to damages due to the defendant's interfering with plaintiff's future profits in the sale of land where defendant restricted memberships in a golf club. The attorneys involved are Clinton F. Jones, P. O. Box 1506, Escondido, California, 92025, (714) 745-4400, and Roscoe D. Keagy, 304 Kalmia Street, San Diego, California, 92101, (714) 239-3861. The transcripts of the trial are presently being prepared, and even though I have given a tentative decision, I will soon be in preparation of the decision of said case. This case involves the complex issue of possibly determining damages based on loss of profits due to appreciation of land values, etc.

4. La Costa Village Homeowners Assn., et al. v.
La Costa Village Company, etc., et al.

This is a case in which the damages may well exceed \$25 million, and there are more than twenty parties involved in this litigation. There are multiple plaintiffs and defendants. I was assigned this case for all purposes; that is, pre-trial motions involving pleadings and the issue of class action. This case is not due to be tried for approximately one year, and the trial time is expected to exceed six months. So far, I have handled all of the pre-trial motions and the case is now ready for determination of the issue of class action and who are members of the class. Attached hereto is a list of the attorneys involved in said action.

During the years 1975 to present Mrs. Gilliam worked as a realtor for BobEarl Corp. Her earnings were approximately \$1,700 to \$2,000 per year. This period of time we were separated, therefore I did not keep track nor do I have knowledge of her income.

The following are a list of corporations, business enterprises and partnerships in which I have some interest which is disclosed.

- a. BobEarl Corporation - Approximately 1972
This is a family-owned corporation which was set up for tax purposes. Barbara J. Gilliam, my wife, is a realtor and this corporation hires her to sell real estate. She is the president and I am the secretary-treasurer.

If I am nominated for said judgeship and if there is a conflict, I will resign and relinquish my interest in said corporation.

- b. Western State College of Law - Approximately 1968
This is a law school which has been in existence for approximately 12 years. I presently serve as a member of the board of directors and for approximately 10 years I have been an instructor and professor of law teaching courses in contracts, torts, community property, and I presently am the head of the trial practice division.

If there is any conflict in my retaining the aforesaid positions to said law school and I am nominated as a federal judge, I will resign said positions with the law school.

- c. Our-Bis Investment Club - Approximately 1970
This is a group of eight men who have met once a month for the last eight years wherein we pay dues of \$25 per month and invest in different projects. My total interest in said club is approximately \$2,500. We have interest in items or assets such as second trust deeds, stocks, bonds, etc.

If my interest and membership in this club is in conflict with my nomination as a federal judge, I would resign from said partnership.

- d. Gray-Dove Investments - 1979
In 1979 I invested \$10,000 with a friend, Ms. Lucy Goldman, for the purpose of buying land and developing it to build six homes, either single family dwellings or condominiums in the Mission Hills area of San Diego. My interest is approximately 1/24, and I expect this over-all business venture to capitalize out at well over a million dollars.

If my interest in this business venture is in conflict with my nomination as a federal judge, I will terminate same.

III. GENERAL

EARL B. GILLIAM

1. Since 1963 I have been a judge. At all times I have attempted to see that all those persons who appeared before me got equal justice.

This has included cases and actions where their driving privileges, freedom, property, and personal relations with others was the subject of controversy.

I submit that a judge has the responsibility to breathe life into the law, to make sure that there is an appearance of justice for all in the courts, and that each litigant receives fair and equal justice. I made this commitment at the time I first became a judge and I have tried to the best of my ability to carry out these principles while serving as a judge.

In addition, I have participated in judge's colleges and seminars for judges. I have been a seminar leader in said courses.

2. An ethical consideration under Cannon 2 of the American Bar Association's Code of Professional Responsibility states, in part, that: a) "Important functions of the legal profession are to educate laymen to recognize their problems, to facilitate the process of intelligent selection of lawyers, and to assist in making legal services fully available;" and, b) "Every lawyer, regardless of professional prominence or professional workload, should find time to participate in serving the disadvantaged." Describe what you have done to fulfill each of these responsibilities.

a. During the mid-60's when our youth were demonstrating I, with two other persons, set up an undergraduate course at the University of California at San Diego to teach college students the appreciation of and responsibility they should have for our legal institutions. Many of the students of this course have since become police officers, employees of the courts, and lawyers.

For more than ten years I have taught law school, teaching first year courses. I also set up a course wherein seniors in law school learn how to try lawsuits.

I have also appeared on panels and lectured to different groups of lay persons regarding the law.

b. Prior to becoming a judge my office was in the disadvantaged area of our city. Much of my work was free. In addition, I volunteered for the court appointments in our courts at a time when lawyers were not paid for representing defendants in both the State and Federal Courts.

I also serve on boards of the NAACP and Legal Aid for my city.

I presently serve on the Senior Citizens Board of Directors, wherein my responsibility is to oversee their legal center, to make sure there is legal assistance for senior citizens.

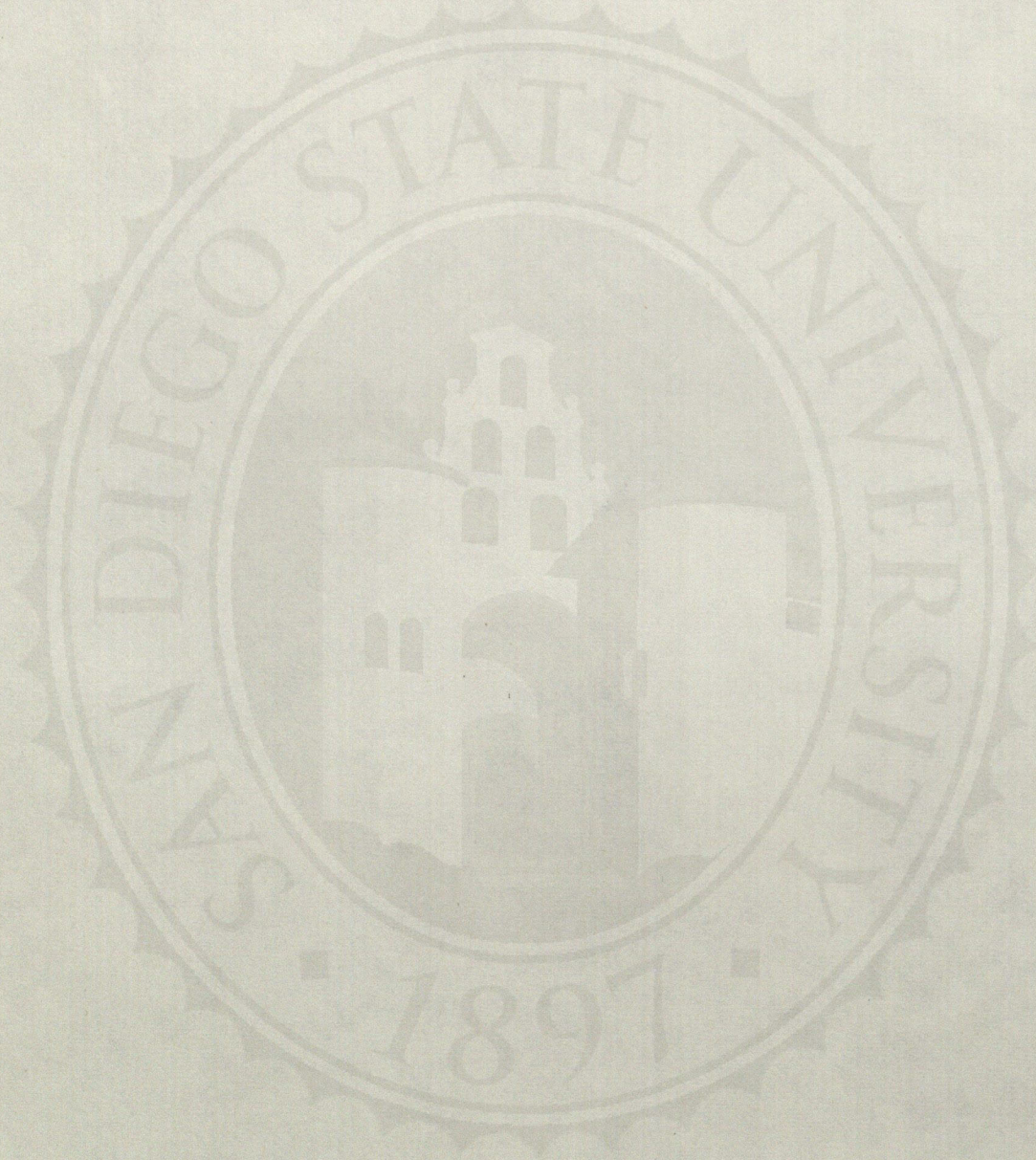

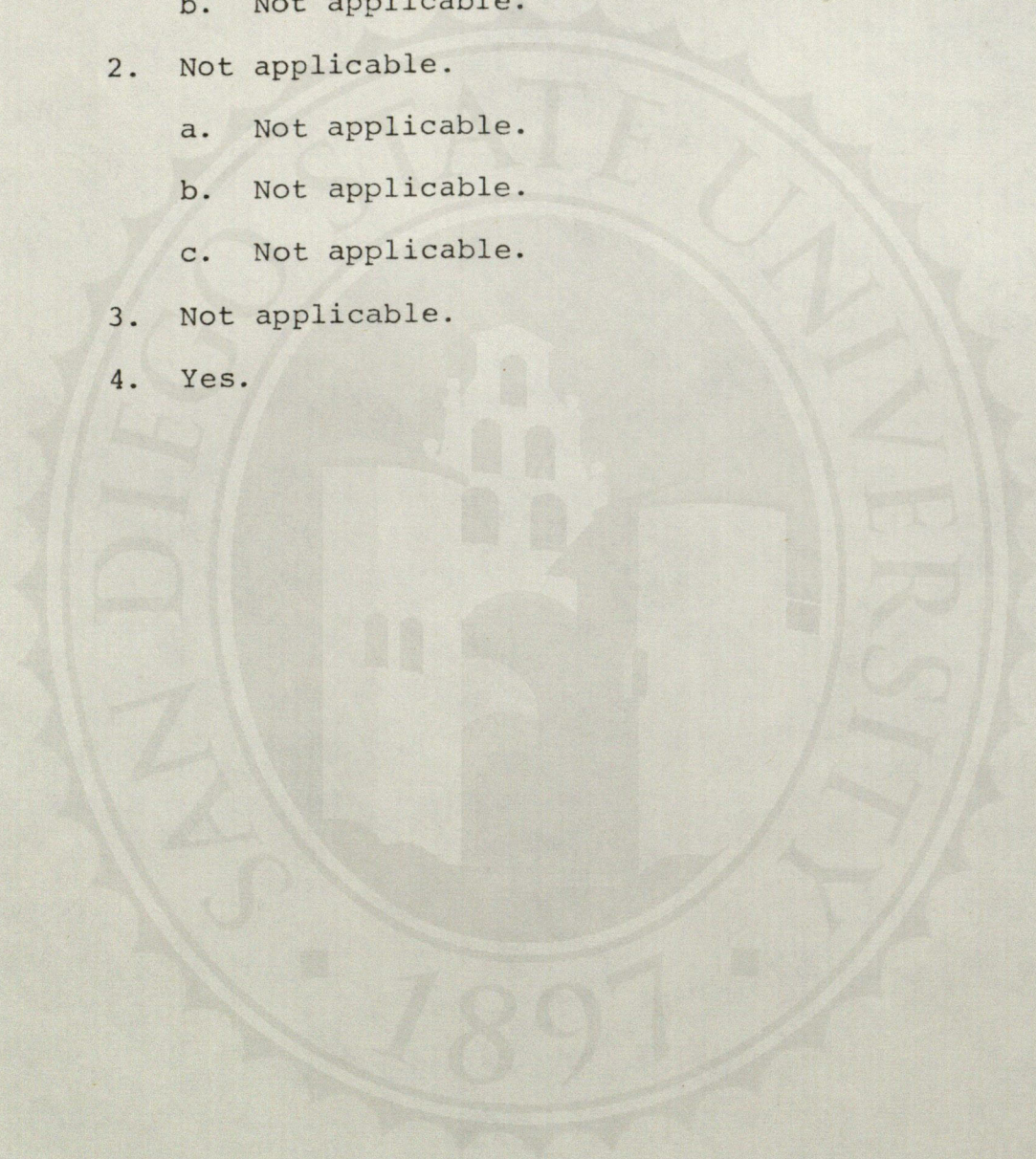

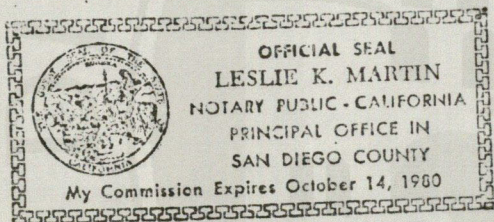
