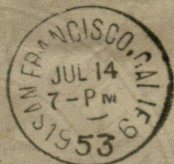

To the Student Addressed:

We are pleased to advise you that your application for admission to our next First Year Class has been approved.

We are obliged to request you and every other First Year applicant (veteran and non-veteran alike) to make an acceptance deposit of \$50.00. In no other way can we be assured of maximum attendance at the beginning of the academic year; in no other way can we avoid the danger that too many applications will be approved. A \$50.00 check or money order, payable to the Hastings College of Law, must, therefore, be delivered here within fifteen days.

If you are a veteran of World War II, both the \$50.00 acceptance deposit and the \$5.00 application fee eventually will be refunded, but not until (1) your qualification for veterans' benefits has been established, and (2) your registration at the Hastings College of Law has been officially confirmed by the Veterans Administration or by a similar agency.

Further instructions concerning registration during the week of September 7 will be given to you after the acceptance deposit has been received.

NO REFUND OF AN ACCEPTANCE DEPOSIT WILL BE MADE TO ANY APPLICANT WHO FAILS TO REGISTER UNLESS THE APPLICANT IS A MEMBER OF THE ARMED FORCES ON EXTENDED ACTIVE DUTY ON SEPTEMBER 7, 1953. THE APPLICATION FEE CANNOT BE REFUNDED UNDER ANY CIRCUMSTANCES, TO AN APPLICANT WHO FAILS TO REGISTER.

If you wish to withdraw your application, immediate word to that effect will be appreciated. Payment of the acceptance deposit is a final commitment; hence, please do not make it unless you intend to become a member of our student body.

To the Student Addressed:

We herewith acknowledge receipt of your acceptance deposit of \$50.00 for the academic year 1953-54.

Registration of First Year students will be held on September 8 and 9; registration hours will be from 9A.M. to 12 Noon, and from 1:00 P.M. to 4:30 P.M. A penalty of \$5.00 will be charged for late registration.

Veterans who expect to attend under the benefits of Public Law 346, 78th Congress, must secure a certificate of eligibility (VA Form 7-1953) from the Veterans Administration and must produce it at the time of registration. Students who will attend under Public Law 16 (disabled veterans), must present an authorization (VA Form 7-1905) executed by the appropriate VA Training Officer. Veterans of the Korean War who expect to attend under the benefits of Public Law 550, 82nd Congress, must present certificate of training and education (VA Form 7-1993).


Existing authorizations to attend other departments of the University of California are not transferable. See the Veterans Co-ordinator at your present college or university, or contact the office of the Veterans Administration, 49 Fourth Street, San Francisco, California, immediately, concerning the procedure to be followed in securing the appropriate authorization.

Veterans who plan to enroll under the California Veterans Educational Institute program, must present the proper form, as issued by the C.V.E.I.

All students (veterans and non-veterans alike) must pay for their books at the time of registration. A medical fee of \$12.00 per semester is payable by each non-veteran student at the time of registration.

Appropriate refunds will be made to veteran students after their registration has been confirmed by the applicable veteran's agency.


Dear Mr. Gilliam:

Many inquiries have been received from disqualified students concerning eligibility for re-examination, and the procedure to be followed. Your attention is called to the following provision of the College regulations:

"A student in the Second Year must attain a weighted average of not less than 70% in the work of that year, or he will be excluded from the College. A student thus excluded will not be permitted to attend classes, but he may secure readmission with credit for the Second Year by retaking, within one year, the regular examinations in all of the subjects of the Second Year in which he received a grade of less than 70%, and by attaining a weighted average of not less than 70% in those examinations."

Disqualified students who desire to take re-examinations in accordance with this regulation must file written requests, specifying the subjects in which re-examinations are to be taken, and accompanied by the \$5.00 fee for each re-examination. Such requests must be filed not later than April 1, 1956.





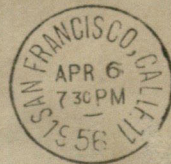
