Showley (high school senior, Republican & San Diegan) & Wilson's reply (6/28) re/ events in the Netherlands and Wilson's assistance to this young man; letters (7/18 & 7/22) re/ Miss Selma Kause (Green Valley, AZ), her book *Mahalo*, retirement and pro Republican view points; notes & letters (July) re/ C. Arnolt Smith seeks Wilson and others assistance in attempting to lease a pleasure yacht for a week at Cannes or Nice but is unsuccessful; letters (6/18 & 7/9) re/ Wilson's concern for James S. Copley's hospitalization and recuperation; letter (7/22) re/ Arvin H. Brown, Jr. (Law Offices of Luce, Forward, etc.) re/ thanks to Wilson for copies of new U.S. Code and the flag flown over the capitol; letter (7/20) re/ Frank C. Owen (Attorney at Law) thanks Wilson for the 1964 edition of the U.S. Code – 7 volumes; letter (7/26) re/ Congressman William S. Mailliard thanks Wilson for the potted plant sent to him while in the hospital; copy of letter (7/20) sent by San Diego Mayor Frank Curran to the Ambassador of Italy, Sergio Fenoaltea, inviting him and his wife to visit San Diego and attend a special concert performed by the S.D. Symphony on Oct. 8th; letters (July & Aug.) re/ Ambassador Fenoaltea had to regretfully decline the invitation; letters (7/20 & 7/26) re/ Wilson sends a constituent maps of Washington as requested; letter, note & telegram (7/8, 7/22 & 8/3) re/ retirement of long time Union-Tribune Publishing Co. employee Fran Ide & Wilson's best wishes – "I will always appreciate the patience you showed me in dealing with me as a budding advertising man;" letters (2/2 & 2/4) re/ high school senior Benjamin Elliott taking a college credit course entitled Political Science 2 seeks information from Wilson to do an oral report on Congress & Wilson sends him copies of the *Congressional Record*; letters & photo (July & Aug.) re/ fascinating details about the interest an 18-year old Finish student in visiting Washington, since his father, as Chief Detective in Helsinki, had assisted the Secret Service when V.P. Johnson visited there in August 1963 – Reino Paavola had received a signed invitation from Johnson to the VP's gallery in the Senate; 2 letters (Aug.) re/ Wilson sends pamphlets on government to 19-year old Miss Charlotte Lehr; 2 letters (Aug.) re/ Wilson appreciates receiving two papers, "God's Space Program" and "Man Looks at Mankind" from Vice President B. F. Coggan (Douglas Aircraft Co., Inc.); office notes, telegram & letter (Aug.) re/ missing son, Jim., of constituent James Mellusi & State Dept.'s help; letter (Aug.) re/ San Diego Attorney David Casey thanks Wilson for sending the U.S. Code for 1964; office note & letter (Aug.) re/ sending booklets to constituent Mrs. Conrad F. Pearson; letter (Aug.) from Bruce Ladd (Admin. Asst., 13th Dist., Illinois) re/ "Congressman [Donald] Rumsfeld has asked me to inquire if it would be possible for you to send to this office a copy of the paper, "Duty as Seen by Lincoln;" letter & telegram (Aug.) re/ reference to copies of Wilson's "Duty as Seen by Lincoln;" letters (July-Aug.) re/ information from Library of Congress on fluoridation of water sent to Sister Anna S.
