Particularly in face of Dem controlled Congress for past 6 years;" 4 page copy of a listing of "Beneficiaries of Private Laws" for 83<sup>rd</sup>, 84<sup>th</sup>, 85<sup>th</sup>, 86<sup>th</sup> & 87<sup>th</sup> Congresses; 9 pages of details on "Beneficiaries of Private Laws and Interested Parties" for the 83<sup>rd</sup> to 87<sup>th</sup> Congresses; 6 legal-sized pages of details on H. R. bills for the 83<sup>rd</sup>-86<sup>th</sup> Congresses; an office note for May 23, 1960 re/ details on Public and Private Bills & Public and Private Law; a letter (7/26/62) from Congressman Harold T. March 27, 1962 a "Speech of Hon. J. Caleb Boggs of Delaware in the Senate" re/ "a joint resolution [with Senator Dodd] to establish a Joint Committee on National Security Strategy;" letters (9/9/61 & 1/62) & attached copies of 87<sup>th</sup> Cong., 2<sup>nd</sup> Sess. H.R. 9835 "A Bill FOR the relief of Charles E. Gardiner and others as introduced by Congressman Morris Udall re/ compensation relief for former members of the U.S. Customs Patrol; letters (1/3 & 1/11/62) & attached 2 page copy of *Congressional Record* re/ "Foreign Service Training Corps Speech of Hon. Horace Seely-Brown, Jr. of Connecticut . . . Tuesday, July 13, 1961."
