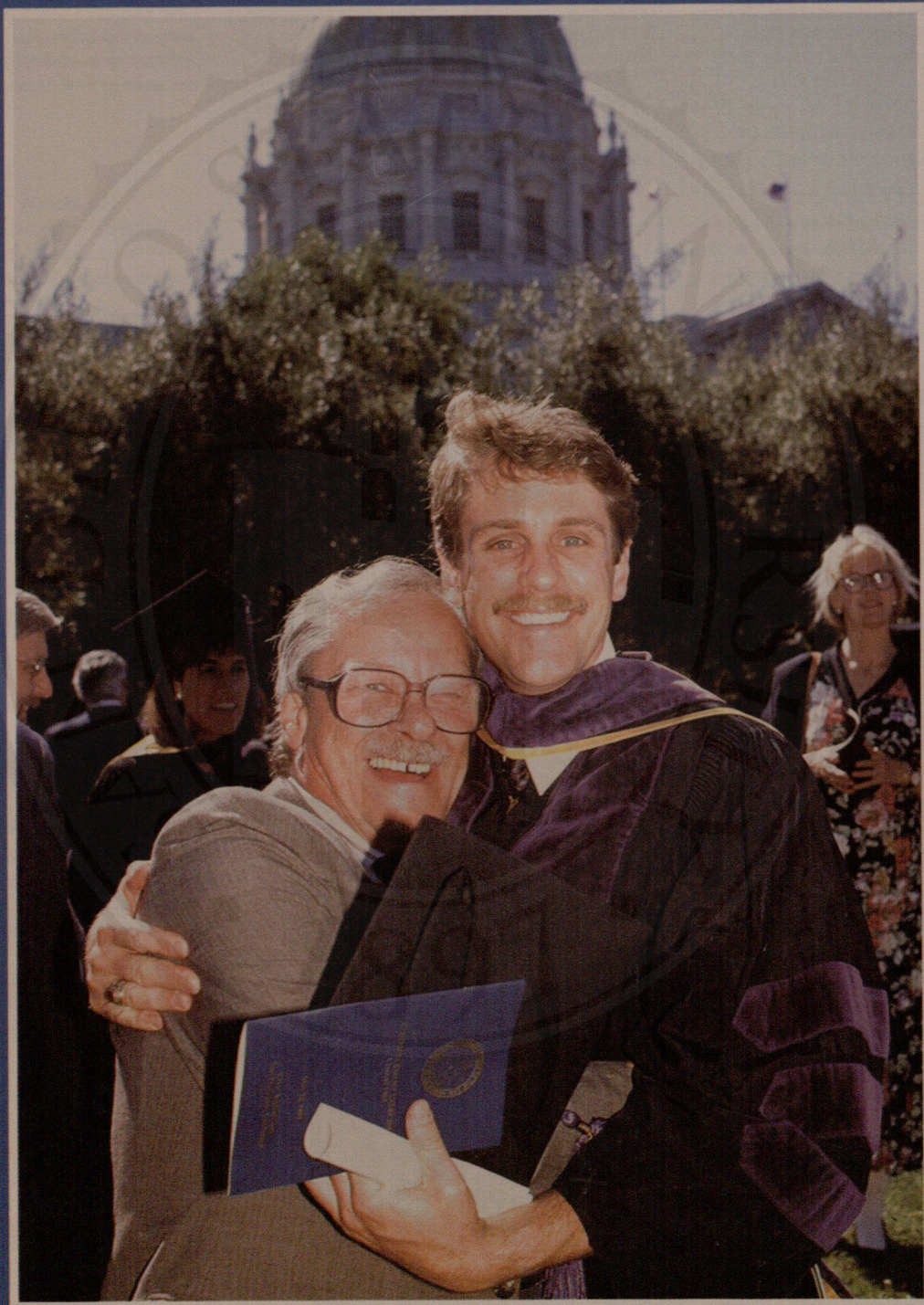

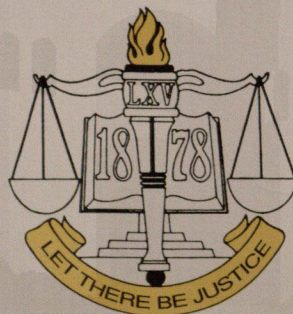

Class of '93 Joins Ranks of Alumni; S.F. Chapter Welcomes 115th Class

The 115th anniversary celebration of Hastings' founding in 1878 — observance of which began with Founder's Day in March — came to an end with a birthday party thrown by the Alumni Association's San Francisco Chapter for the 115th entering class this fall. The party followed May's graduation of the Class of 1993, that other major annual transition within the Hastings family.

The 393 members of the Class of 1993 received their Juris Doctor degrees at San Francisco's Civic Auditorium. Commencement speaker Rep. Maxine Waters of Los Angeles called upon graduates to "remember well the wisdom of William Jennings Bryan who advised, 'Destiny is not a matter of chance. Destiny is a matter of choice.'

"I hope your destiny," she added, "includes commitment to public service — to defending and advancing the interests of the less powerful in our society and to a conception of justice bound not simply to legal definitions, but directed toward helping each and every individual pursue her or his God-given potential."

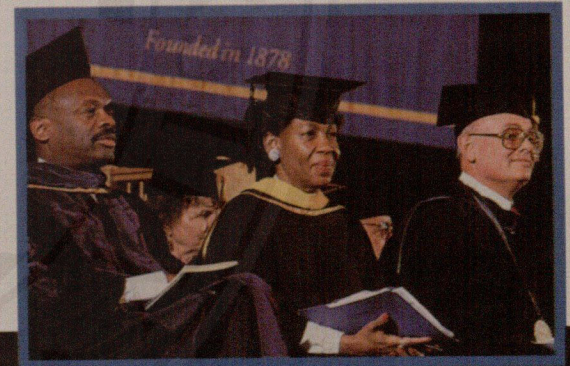

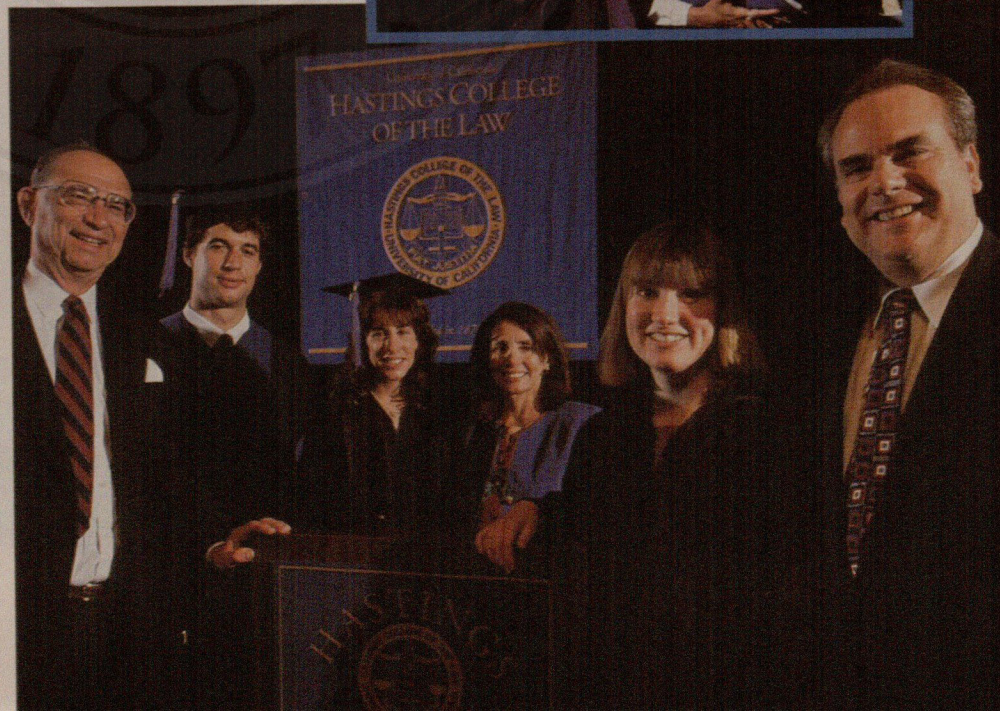

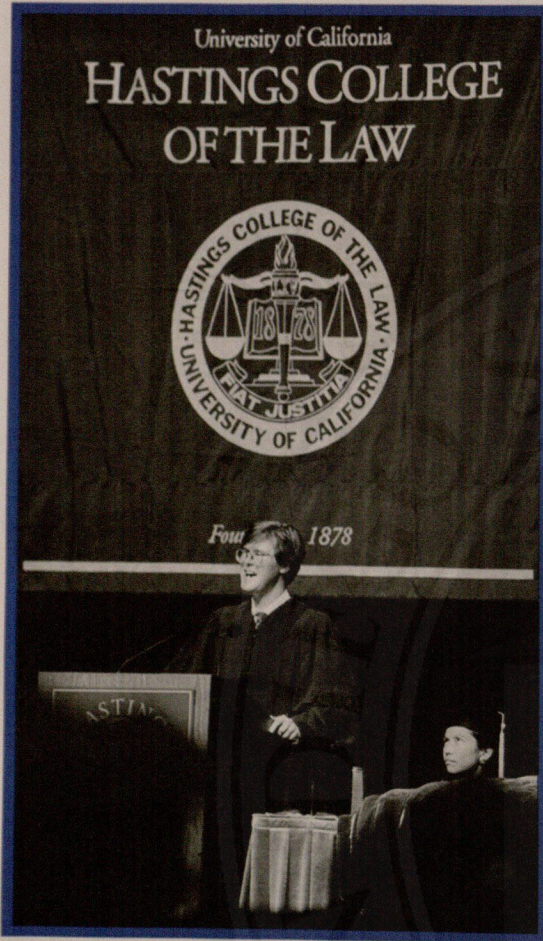

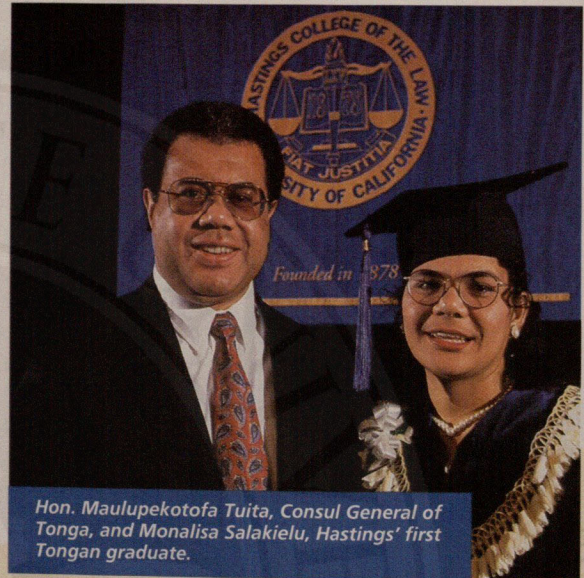

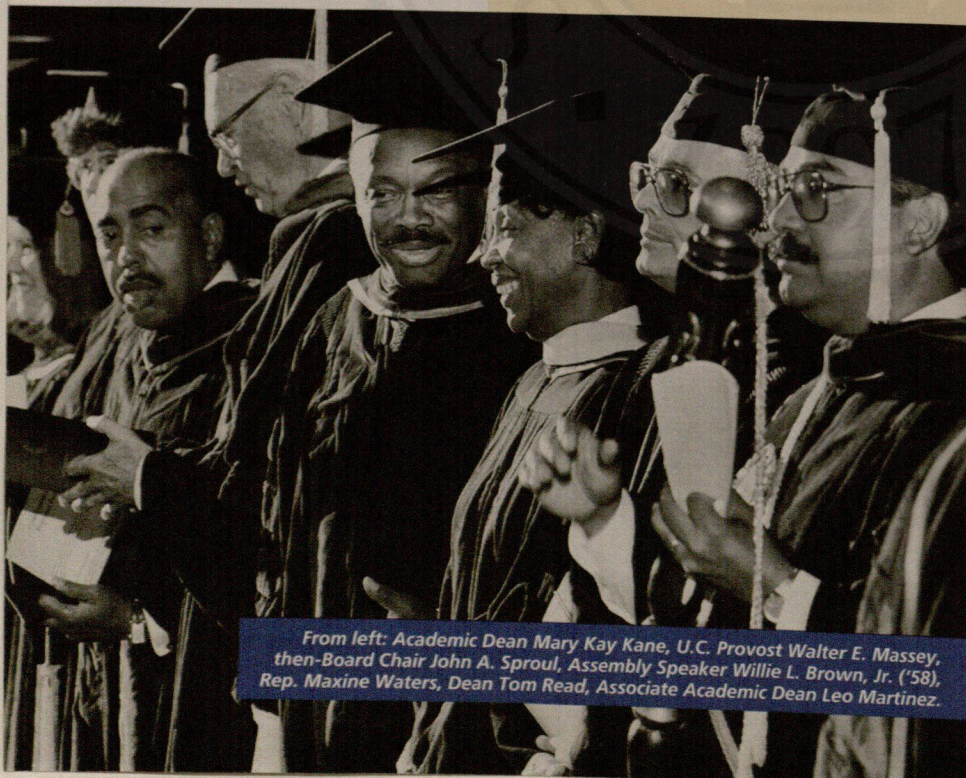

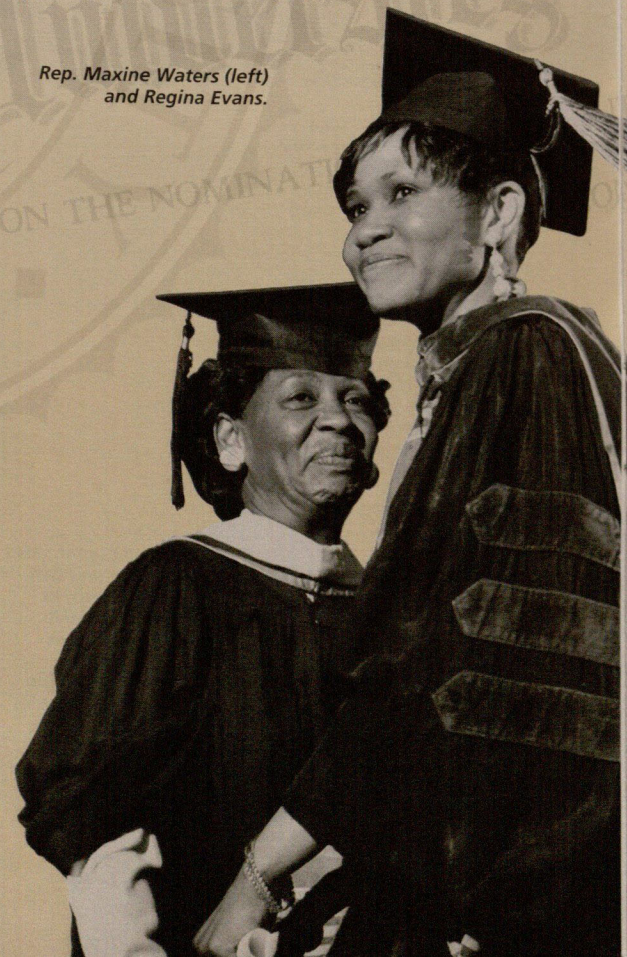

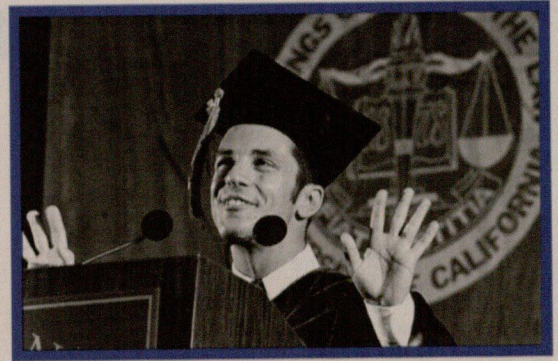

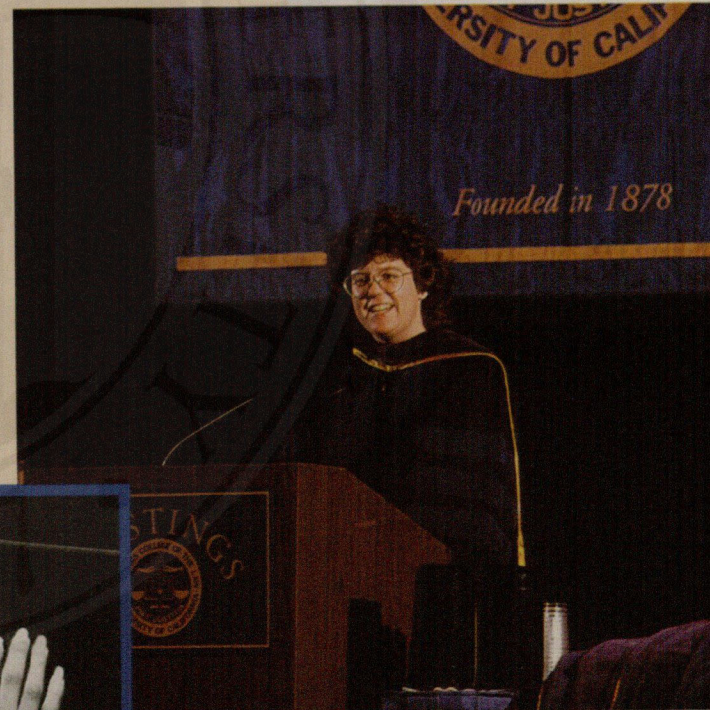

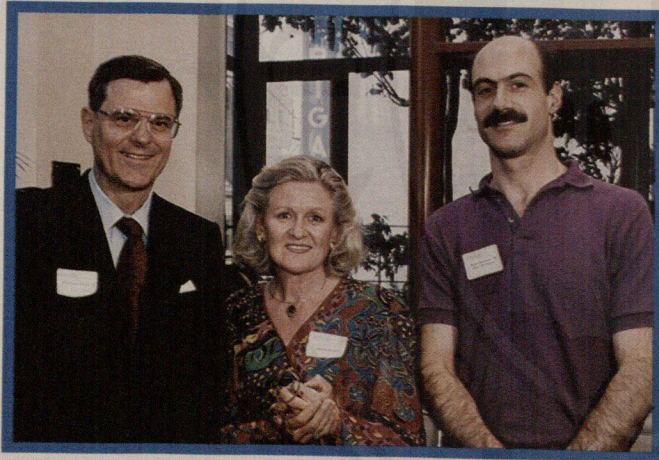

Alumni Around California Welcome the 115th Class

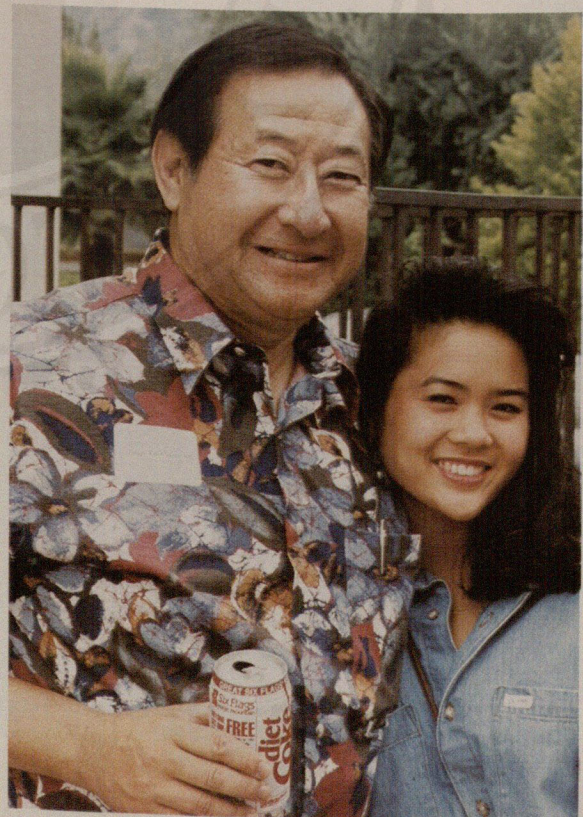
While the San Francisco Chapter this year welcomed the First-Year class with a birthday party marking its entry as the 115th class, chapters around California sponsored receptions and barbecues over the summer to welcome new Hastings students from their regions. This year's entering class of 419 was drawn from an applicant pool of 5,423 — the second highest in history, and more applicants than at any other University of California law school. Their average age is 26. They come from 25 states. They represent more than two dozen races and cultures. While entering students represent 112 different undergraduate universities, the largest numbers came from U.C. Berkeley and UCLA.

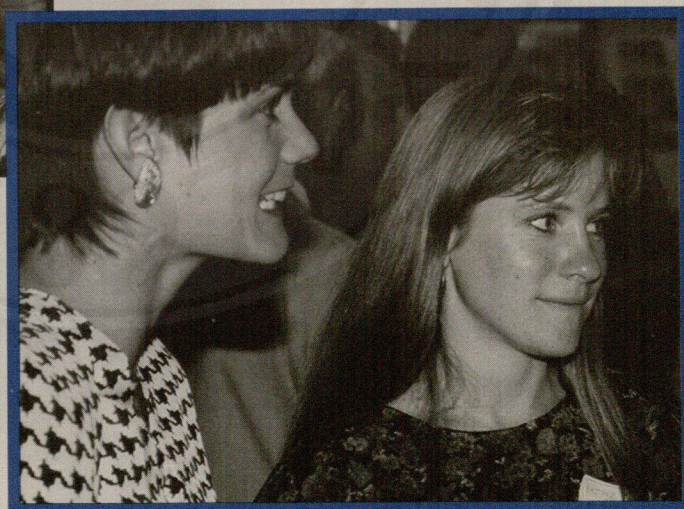

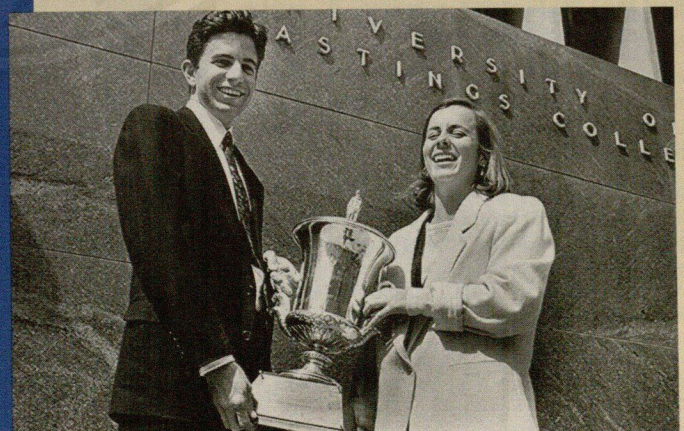


Marine World Trip for Tenderloin Kids

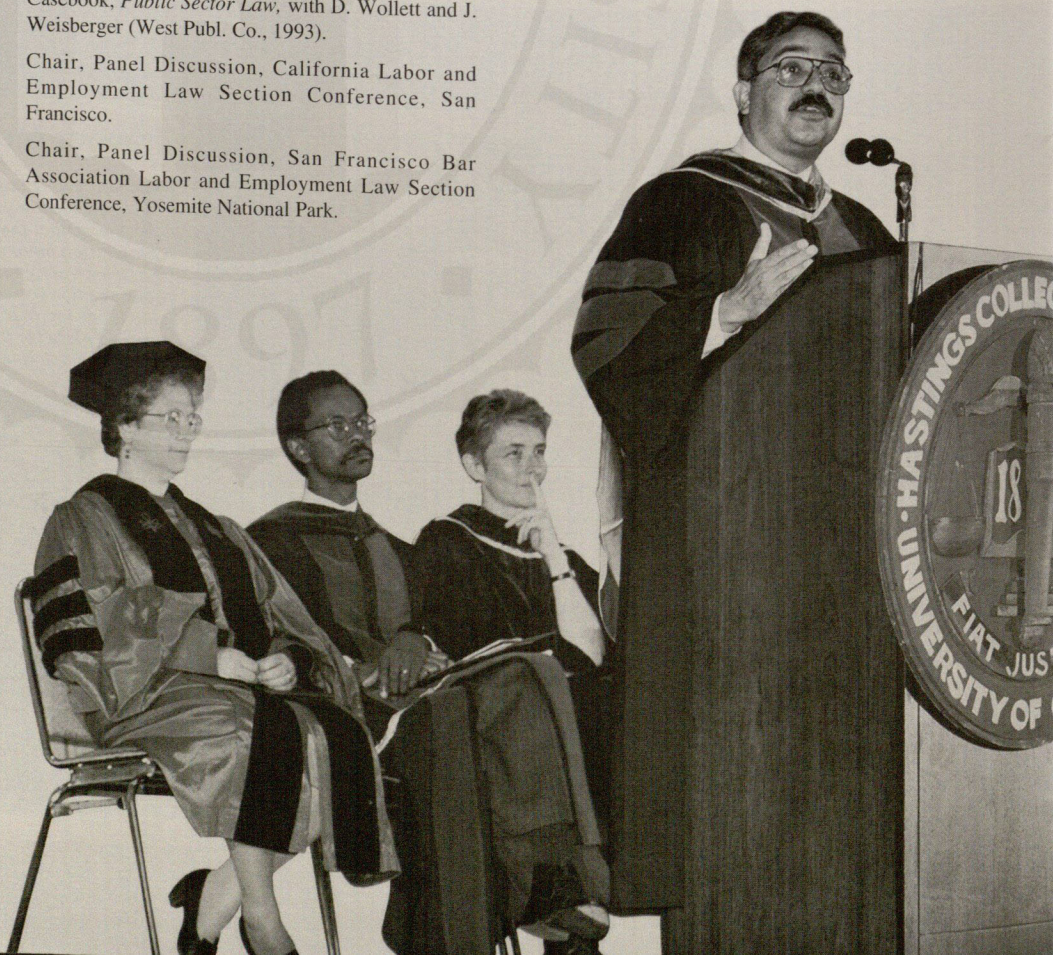

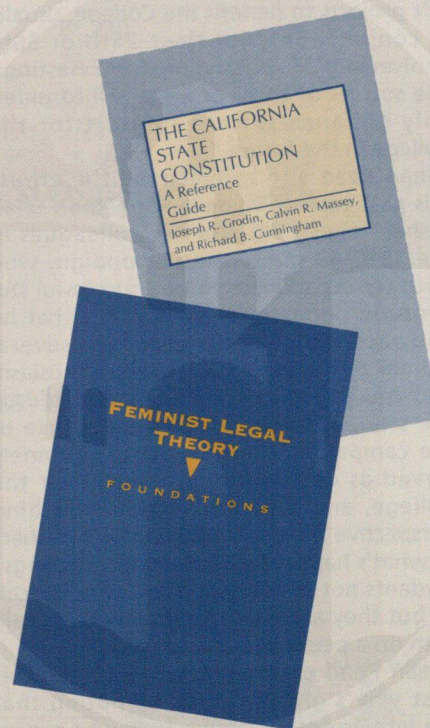

Annual Fund Gifts, Donors Both Up in 1992-93

For the fourth year in a row, overall giving to Hastings has exceeded the \$1 million mark. In recently announcing the annual gift figures, Dean Frank T. Read saluted the leadership efforts of the National Chair of the 1992-93 Annual Campaign, Peter W. Davis ('69), and the respective class agents, among others, for keeping Hastings' fundraising program "on the ascendancy, especially during a period of continuing decline in the overall economy.

"Despite the fact that the general economic climate recently has not been particularly conducive to charitable giving, gifts to the College's Annual Fund were up nearly 11.5 percent this past year, increasing from the \$146,988 of such gifts received in 1991-92 to \$163,752 of Annual Fund gifts reported in 1992-93," said Dean Read.

"Moreover, the number of the College's donors was up nearly 3 percent this past year, increasing from the 1,630 donors reported in 1991-92 to 1,676 donors in 1992-93. I simply cannot overemphasize the significant roles that were played in the success of this past year's campaign by Mr. Davis, by our very energetic and dedicated class agents, and by our very effective and loyal members of the 1066 Foundation's Board of Trustees. Their combined efforts truly have maintained the College's development program on an upward path, notwithstanding the many adverse effects of the ongoing recession. I cannot thank them enough for all they do for the College."

Dean Read also noted that Hastings alumni once again played a vital role in the success of the Annual Fund Campaign, with nearly 90 percent of the donors to this past year's campaign coming from the ranks of the College's graduates. As Read indicated: "Our alumni continue to remain loyal to their alma mater, providing much needed private support during a period when the State's direct appropriation to the College has been reduced quite dramatically. Indeed, the reduction in State assistance to the College over the past three years has totaled nearly \$2.5 million. The commitment of both time and financial resources to the College by our alumni during these particularly lean economic times could not be more appreciated — or more beneficial, for that matter!"

The overall results in the competition among classes for the highest participation rate in the Annual Fund Campaign were, once again impressive. For the first time, two classes shared the spotlight in terms of

the highest rate of participation, with both the Class of 1938 and Class of 1944 having the participation of 50 percent of their class members in the 1992-93 campaign. For the second year in a row, the Class of 1974 provided the greatest number of donors to the campaign, and the members of the Class of 1966 contributed, in the aggregate, the largest overall gift total.

"All in all," according to Dean Read, "the members of the various classes responded most impressively to the appeals of their respective class agents. Moreover, several of the classes are either now considering, if not currently undertaking, major class gift projects to benefit the College, usually in conjunction with their 25th or 30th anniversary of graduation from Hastings. The success of these projects will considerably enhance private support for the College in the future."

Dean Read also commended the efforts this past year of Student Phonathon Chair Aisha Tinker ('94) and her colleagues in the 1992-93 phonathon campaign, who once again conducted a very successful student-run phonathon. Read noted that he had received compliments from several alumni concerning "both the enthusiasm and courtesy that were demonstrated by the student callers during the course of the campaign. These students genuinely served as goodwill ambassadors for the College, and they provided a refreshing perspective for alumni to hear with respect to what's happening at Hastings. Hastings students not only are first rate academically, but they are a delight to meet and talk with on a personal basis, as well."

Dean Read concluded his report on this past year's giving results by noting that the late Professor Jerome Hall, who served as a Sixty-Five Club member from 1970 until his retirement in 1989, made a most generous bequest to the College of more than \$250,000. Dean Read indicated that Professor Hall had already left a legacy of tremendous scholarship and several generations of lawyers who revere him as a great teacher. "Hall's legacy," Read said, "will continue to benefit students at Hastings for generations to come because his most generous bequest was designated, in part, to establish a lectureship to bring distinguished lecturers to the campus. Professor Hall's lifelong commitment to scholarship and its transmission to students could not have been more appropriately demonstrated, perhaps, than through the endowment of this lectureship."

Alfred M. K. Wong ('64) is serving as National Chair of Hastings' Annual Fund Campaign for 1993-94. He is Managing Partner of Takushi, Funaki, Wong & Stone in Honolulu. He is active in many legal and community organizations, and as a Governor of Hastings' Alumni Association. The National Chair works closely with the Hastings 1066 Foundation and class agents in financial partnership with the College.

Dean Frank T. Read, in announcing the appointment, noted that Wong "continues the tradition of prominent and distinguished alumni serving as National Chairs." He also noted that many alumni will find it more advantageous to make Annual Fund donations this year than last in light of Congress' recently enacted tax-rate increases that are retroactive to January 1, 1993. Gifts of non-cash property may be particularly attractive, primarily because Congress restored full deductibility for gifts of appreciated securities and other qualified property.

Wong believes that with cut-backs caused by one of the worst recessions in California history, it is more important than ever for alumni and friends of Hastings to join in the private-public partnership that is the growing financial base of the College.

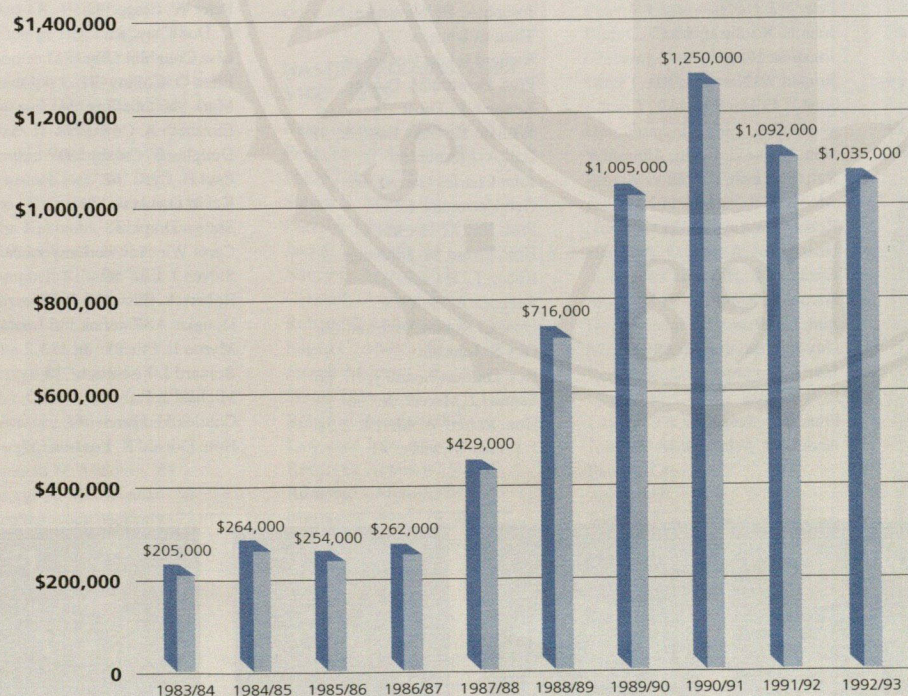
"During the two past years," Wong notes, "Hastings hosted two successful U.S. Attorneys General Forums. We set this precedent because of Hastings' prestige among law schools nationally. This is because of our academic excellence, top faculty, high admissions standards, and successful graduates."

"Funding sources that enable us to achieve these standards," he adds, "are grants, fees and tuition, State funding, and private contributions. Sadly, State funding is being cut for the third year in a row. What are our options? We are raising funds from the private sector and cutting our budget. Both roads must be travelled conscientiously. And we ask alumni and friends to make the extra effort to contribute more this year to maintain the fine reputation of Hastings."

Fiscal Operations

During the fiscal year 1992-93, the College suffered a loss of \$950,000 in State and fee/tuition funding. Through sound fiscal management, a reserve from prior years, and a thorough scrutiny of all College expenditures, the College was able to absorb the funding loss without any noticeable reduction in service. In addition, due to an early retirement program offered by the University of California, the College has been able to downsize its organization through attrition. The salary savings realized through this downsizing have assisted the College in meeting the reduction in funding.

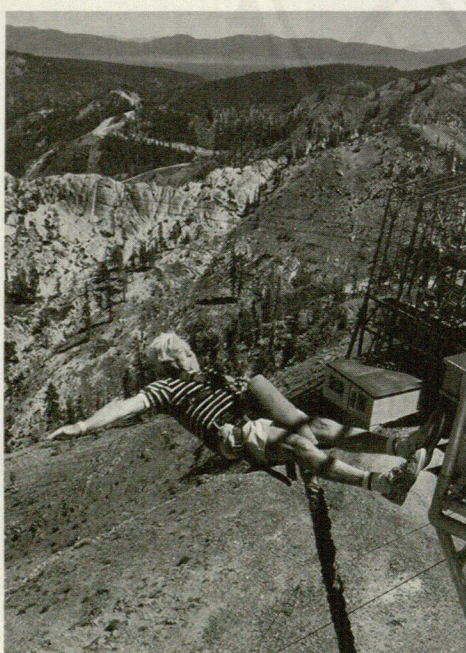

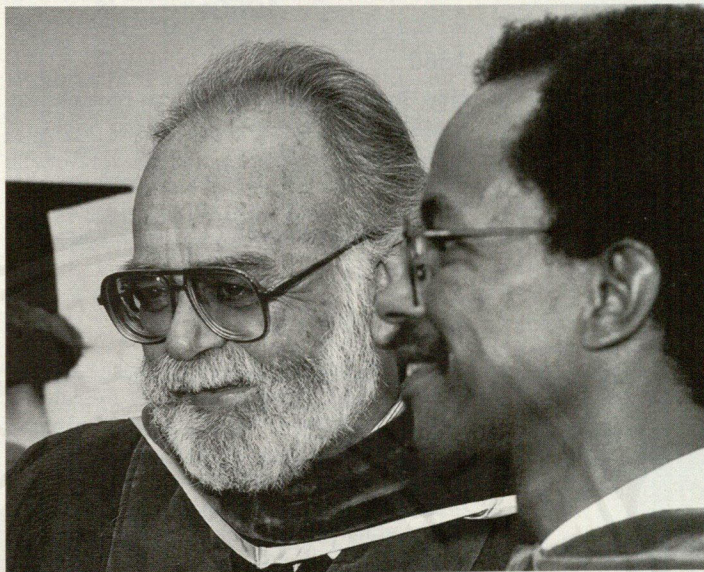
Ralph Abascal Awarded 1993 Kutak-Dodds Prize

Ralph Santiago Abascal ('68), General Counsel of California Rural Legal Assistance since 1975, was awarded the 1993 Kutak-Dodds Prize for his commitment and work as an advocate for the poor and disadvantaged. Abascal recently retired from Hastings' Board of Directors upon completion of a 12-year term.

The Kutak-Dodds Prize is awarded annually in memory of the late Robert J. Kutak and the late Kenneth K. Dodds, former partners in the Omaha office of Kutak, Rock & Campbell. Abascal's career has included personal involvement in a wide range of issues

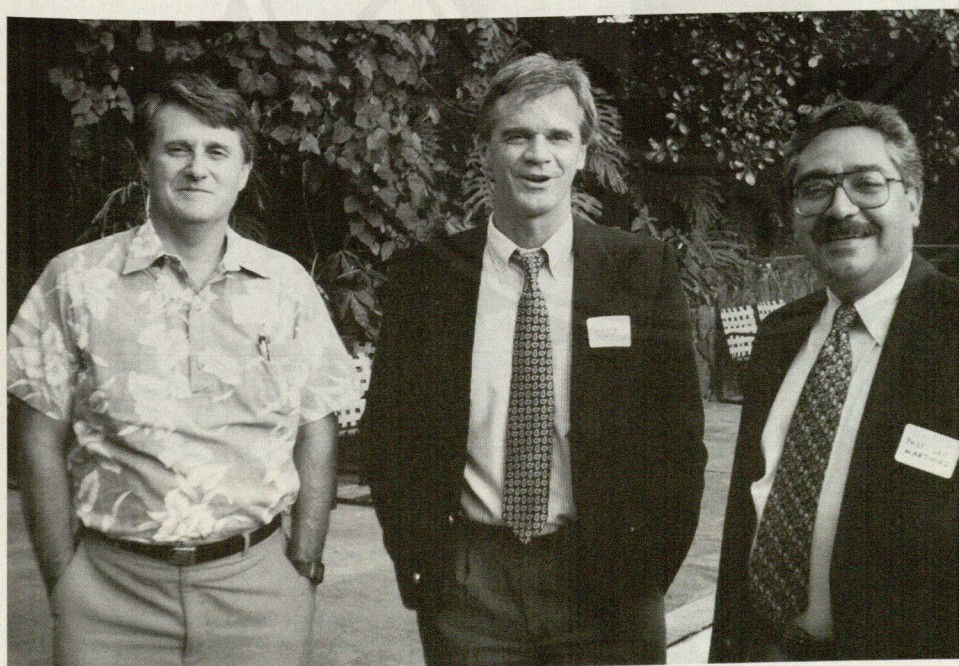


Ralph S. Abascal ('68), left, with Professor Richard A. Boswell

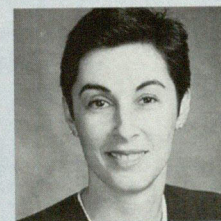

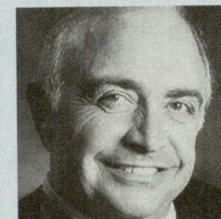

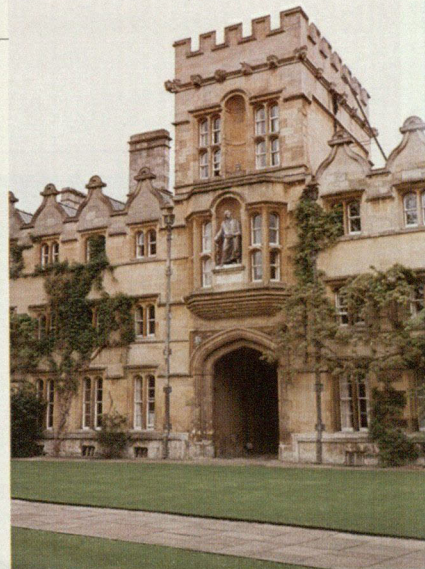

For the first time, Hastings College of the Law will combine academic resources with University College, one of the oldest and most prestigious colleges of Oxford University, to present a week long program of continuing legal education in Oxford, England, **August 6-14, 1994**. The program is divided into two topics of general interest — “Advising Clients Doing Business in the New Economic Community” and “Litigating in London.” The program will allow participants to qualify for 12 hours of MCLE credit (one year's requirement).



TOPICS & INSTRUCTORS

“Advising Clients Doing Business in the New Economic Community” will highlight general business, intellectual property, environmental and tax issues of which American lawyers should be aware.

“Litigating in London” will provide a solid background in the structure of the English legal system.

We will talk with judges, solicitors, and barristers about comparative problems in advocacy and ethics. Another topic, which crosses the boundaries of transactional and litigation practice and which is a required MCLE topic beginning in 1995, is gender bias. We will learn about comparative problems of women in law. The instructors will include distinguished lecturers from Oxford University, Hastings College of the Law, as well as practicing judges, solicitors and barristers.

A special certificate of participation in the Oxford/Hastings Institute will be awarded to participants.

ACCOMMODATIONS & SOCIAL EVENTS

Participants in the program have a choice of accommodations. They may choose to “live in college,” experiencing the cozy charm of 17th century rooms with beamed ceilings. University College has been the home of many famous politicians and scholars, including former Prime Ministers Clement Attlee and J. Harold Wilson, the poet Percy Bysshe Shelley, the teacher and writer C.S. Lewis, and the astrophysicist Stephen Hawking. And yes, University College was where a young American Rhodes Scholar didn't inhale.

You can also opt for more modern accommodations at the nearby Eastgate Hotel, a Forte Heritage hotel, complete with bathrooms en suite. All participants will take some of their meals in the handsome dining hall of University College, will take their lectures in the College's rooms, and will have access to the lovely public grounds of this historic College.

You will be offered the opportunity to explore Oxford and its environs. Oxford is within easy distance to Stratford Upon Avon, the home of William Shakespeare and the Royal Shakespeare Company. Other excursions may include the Cotswolds, the town of Bath, Stonehenge, and Blenheim Palace. Other social activities, such as golf and tennis, also will be available.

COST

The Continuing Legal Education (CLE) part of the program will cost \$1,400. Accommodation and airfare packages are available at varying prices. 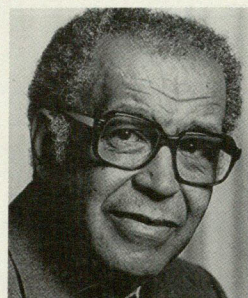


The Second Annual Attorneys General Forum

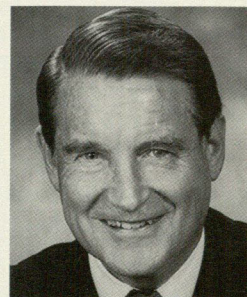
